**DISCUSSION**

1. The proposed East Oakland Sports Center project would be located at Ira Jenkins Park, at 9175 Edes Avenue (APN 044-5053-001-06) in East Oakland. The phased project would include Phase I to be constructed by March 2010, and a Master Plan to be constructed in the future ([CMDV08-027/ER06-0017](#)). Phase I of the project would construct a new recreational facility up to 26,300 square feet in size including: an indoor recreational swimming pool, a dance/exercise room, a multi-purpose room/learning center, and other accessory activities, as well as an 84-space parking lot. If sufficient funding is available, a fitness/weight room and two outdoor basketball courts would also be included in Phase I. The Master Plan would construct an additional 35,300 square foot facility including: a two-court basketball gymnasium with an elevated running track around the interior, as well as an outdoor competitive swimming pool, two baseball fields, three soccer fields, and a 119-space parking lot. The existing 15,500 square foot recreation center and the adjacent 60-space parking lot would be removed under the full build-out scenario.
