1. **Alta Bates Summit Medical Center (ABSMC) Seismic Upgrade and Master Plan:** Preliminary Design Review of proposed Phase 1 improvements at the ABSMC campus including a new 11-story patient care hospital tower, a 7-story parking garage and on-site circulation improvements. The location of these facilities would be along Hawthorne Avenue between Webster Street and Elm Street. The hospital tower is proposed at the site of the current Samuel Merritt University classrooms and dormitory, which would be demolished. The parking garage would be located on a site that currently contains two small medical-related buildings and surface parking. The Medical Center will have sponsored three community workshops prior to this Design Review meeting to obtain community input and comment. Staff is not requesting the Design Review Committee to make any formal recommendation on this project, but only to provide feedback and comment to the applicant and staff based on the preliminary designs.
