1. **The City Center Block T-12** project site is located on the block bounded by 11th Street, 12th Street, Jefferson Street, and Martin Luther King, Jr. Way (APN **002-0027-007-00**). The proposed mixed-use project entails the redevelopment of the site with a 23-story building containing approximately 621,000 square feet of office space, 10,700 square feet of ground-floor commercial space, and 220 - 250 structured parking spaces. The Block T-12 project is the third block proposed for development as part of the phased four-block City Center Project (PUD99-215). 2. **Mountain Boulevard and Keller Avenue:** Preliminary review of the **Oak Knoll Community Master Plan**, a mixed-use development project proposed for the former 180+ acre Oak Knoll Naval Medical Center (NMCO) site. The master plan proposes development of up to 960 residential units, 82,000 square feet of commercial building area for neighborhood-serving retail and service uses, retention of the Club Knoll clubhouse structure for community use, land exchange with the Seneca Center, restoration of Rifle Range Creek and preservation of up to 50-acres for permanent open space.
